Packaging



- Core tags must be on all product to contain at the minimum the following:
 - Part number
 - o Description
 - Lot Number
 - Mfg Date
- Exterior identification must contain at the minimum the following:
 - Part number
 - Description
 - o Lot Number
 - o Mfg Date
 - o Purchase order
 - o Quantity per Roll

Film arriving at Create-A-Pack from vendors should conform to the above specifications, and will be identified with the following reference code: [governing document] – [equipment application letter] – [wind direction]. For example, "Vendor Film Roll – A - 4" refers to film following the standards of this document, with specification "A", and a wind direction of 4.
